With reference to the above, kindly note that shares of Binani Zinc Limited (BZL) (CIN : U27204WB2000PLC091214) were allotted to the shareholders of Binani Industries Limited (BIL) (CIN : L24117WB1962PLC025584) in the year 2004 (record date 30<sup>th</sup> April 2004) on hive off of the Zinc division of Binani Industries Limited to Binani Zinc Limited

The shares were allotted to the shareholders of BIL in addition to their holding in BIL in the ratio of 13:3 shares (i.e. 3 shares of BZL were given for every 13 shares held in BIL).

These shares of BZL allotted in the year 2004 can be dematerialized under ISIN INE310H01010, however the shares cannot be traded in the secondary market as the listing application made by the Company to BSE was rejected on technical grounds.

It may also be noted that Binani Zinc Limited is a subsidiary of Binani Industries Limited. Binani Zinc Limited has not declared any dividend since the date of allotment of shares. The name of Binani Zinc Limited has been changed to Edayar Zinc Limited. A change of name sticker is attached herewith to convert the same to shares of Edayar Zinc Limited.

Sub: Non Receipt of Refund Orders for Application Nos. B3556910 and B3556909 in respect Public Issue announced by the Company (erstwhile Binani Zinc Limited) in the year 1994.

With reference to above, please note that we had already informed you vide our earlier letter dated 4<sup>th</sup> May 2017 that Refund Orders bearing numbers 014462 and 014463 for Rs. 3000/- each were encashed at your end as per data provided by our Refund Bankers - Federal Bank (Aridheri Branch). A copy of the paid list from the Bank was also sent to you as proof of encashment which is again enclosed herewith.

However we are once again in receipt of a similar complaint letter from you through SEBI SCORES portal. SEBI has requested us to provide you with the details of the bank account where the said refund orders were encashed. Since this is a very old case and nearly twenty three years have passed, we request you provide us with either a certificate from the bank that cheque nos. 810971 and 810972 (which were issued to pay the application money) have been issued by that bank. In the alternative a copy of the bank statement showing debit from the passbook evidencing payment made from that bank account at the time of payment of the application money may also be provided.

We also request you to provide us either with a certificate from the same bank that the refund orders bearing numbers 014462 and 014463 (validity from 23<sup>rd</sup> April 1994 to 22<sup>nd</sup> July 1994) have not been credited to that bank account or bank statement of the said bank account in between 23<sup>rd</sup> April 1994 to 22<sup>nd</sup> July 1994.

Upon receipt of the abovementioned documents we would be able to proceed further into the matter.
